## INTRODUCTION

Kashkadarya, a vital administrative province in Uzbekistan, is in a unique position to leverage its natural resources, agricultural activities, and emerging industrial sector to foster socio-economic growth. However, the region's potential hinges on the effective management of its local taxes and levies.
