As a result, new forms of effective use of technologies, division of labor, specialization, existing production and rational use of technological capacities are emerging or the previous ones are being improved. The dynamics of the level of development from day to day show that rather than the independent development of a single economic entity, it is considered that the operation of a business through the establishment of proportional relations with several related entities is a guarantee of solid economic growth.

How different approaches of the economy at the international and national level in industrialization are manifested in practice and the measures that should be implemented in this direction in our country were studied. The advantage of the method is that it is the most important thing to do now.

LITERATURE REVIEW

Researches on the introduction of innovations in industry are mainly focused on innovative systems, their implementation laws in local environments, and the application of public policy to innovation in networks, the presence of clusters or interregional innovation levels, and the influence of internal and external factors, and this process is based on classical innovation approaches. reflected.

However, the introduction of industrial cooperatives is often considered a phenomenon that occurs at the level of large enterprises. In this study, we analyzed the issue of innovative development at the macroeconomic level.

The emergence of the post-industrial economy or the knowledge economy influenced the changes in economic content, types, forms, methods and methods of production cooperation. Modern problems of international industrial cooperation were studied by N. V. Vorokh, A. N. Bykov, Yu. F. Kormnov, A. A. Maltsevsh and others¹.

G. E. Ershova, Yu. B. Klyuev, A. V. Makarov, Yu. Khokhlov, S. B. Shaposhnik, L. F. Shaybakova, N. V. She-lyubskaya and others. In addition, the theory of cooperation in industry, its economic and organizational foundations, social aspects, conceptual foundations of production cooperation were researched by scientists from the CIS countries M. N. Tugan-Baranovsky, N. D. Kondratev, A. V. Chayanov, N. P. Makarov, , I. V. Yemelyanov².

RESEARCH METHODOLOGY

The purpose of this study is to analyze the practice of introducing cooperation between enterprises in the industry, which is the main link of the national economy as a complex socio-economic system, and the causes of existing problems. In order to assess the state of the existing potential of the national economy and eliminate the shortcomings in the implementation of high-tech developments, the following tasks are set:

- to study the experience of the world's leading countries in implementing and improving the processes of industrialization and mastering the aspects suitable for the potential of our country;
- to determine the current trends and prospective directions of the transformation of the local economy, taking into account the specific characteristics of the international experience of neo-industrial development on cooperation.
- study and master the factors that contribute to the innovative development of the industry and the improvement of production in terms of quality and quantity

Factorial, historical, statistical, comparative and systematic methods of analysis, expert evaluation method were used in the research, which allowed the author to solve the tasks.

ANALYSIS AND DISCUSSION OF RESULTS


One of the main conditions of advanced development is to combine the efforts of many economic entities. The stability of the enterprise is determined by the sum of its unique resources, the level of efficiency of their use and good conditions for production cooperation with other industrial enterprises of the region or industry. Industrial cooperative interaction compensates for the lack of certain resources due to their redistribution in a certain enterprise, which ensures the continuity of the cycle of reproduction.

The economic model related to the preparation, storage and delivery of fruit and vegetable products to the consumer within the framework of the industrial products cooperative should include the following issues (Pic. 1).

It can be concluded from the above model that the activity of the production cooperation model directly causes the development and effective movement of the country's economy in many directions. As you can see, the cooperation of direct production processes leads to the formation of the trajectory of production expansion in the economy. By the production trajectory, we can understand the formation of certain production directions and specialization on a specific product. This, in turn, creates an opportunity to divert the main resources in different directions at the national level. Apart from this, there are many other advantages highlighted in this model.

In addition to the above model, the ability of cooperation of industrial units and enterprises to solve social problems, to form high social activity of the country's population creates optimal conditions for increasing the economic efficiency of the form of management of cooperation of industrial sectors.

The activity of cooperatives in industry as business entities is influenced by internal and external factors, and their lines of influence are often contradictory. Internal - this is the activity of cooperative networks and enterprises, external-market competitive environment and state institution. These factors represent their own interests, their inconsistency creates inconsistency in the management of cooperative processes.

As a form of management, the components of the cooperation efficiency mechanism are considered differently. Organizational and economic processes of any form of industrial cooperation should include structures that create and ensure the functioning of the mechanism of coordination of these interests and thereby ensure their effective operation. These include public institutions, the competitive environment, shareholders and employees. The interaction of the cooperative mechanism and efficiency as an economic form is reflected in Table 1.

In particular, it is possible to increase the possibilities of improving production with the help of scientific and technical progress. Industry, especially heavy industry, which is its most important sector, is the basis of expanded reproduction in the country. It reproduces material and technical means for itself and other industries, and simultaneously improves social and production relations between members of society. A reasonable question arises as to how this process can be achieved or how cooperation is related to scientific and technical progress. In an industrial cooperative, several different economic subjects unite to organize a specific economic activity, at this point they share or divide the existing level of development among the members of the cooperative, and in this process, the level of scientific and technical achievements is observed to improve among the rest.

As a result of establishing cooperation between industries, the possibility of optimal distribution of resources is one of the above advantages. ensures that the plan is launched. As a result, labor force dynamics are improved at the macro-economic level and the social consequences of unemployment are avoided.

In order to theoretically justify the processes related to the development of the structure of industrial sectors and enterprises, it is necessary to analyze and put into practice the theoretical work done in this direction. The theories of the development of industrial sectors and enterprises are based on economic and social aspects in several directions, and on this basis it is emphasized that there is a variety of industrial structures and network relations.

Currently, the rapid increase in the number of the population puts a burden on self-production, which creates the need to quickly provide the needs of the population, and in this case, the few existing enterprises in the market are unable to cope with high demand. Production, transportation and sales processes take a lot of time and require high technologies. In this case, industrial cooperation helps to solve these problems efficiently and in time.

Taking into account these factors, it is considered as an important task to bring the processes of industrial cooperation to a new level, as we learn international experience from year to year. It can also be seen in the decisions made by the widow. In particular, the decision of the President of the Republic of Uzbekistan No. PQ-4302 dated May 1, 2019 "Measures to further develop industrial cooperation and expand the production of products in high demand" or PQ dated January 24, 2022 - No. 99 on "Measures to create an effective system of development of production and expansion of industrial cooperation in the Republic" and other decisions and decrees are direct evidence of this.

All this means the need to study the phenomenon of industrial cooperation in detail, put it into practice, and determine the extent of its influence on the sustainable economic growth of the region.

In the scope of implementation of the above-mentioned measures, progress was also made in the implementation of the "Road Map", which is considered important for the expansion and improvement of cooperation of industrial sectors and enterprises, while benefiting from mutually developed innovative achievements of Uzbekistan and Kazakhstan. It was stated that there is a mutual desire to develop cooperation in this direction, including the development of new promising projects and to attract entrepreneurs to joint business cooperation.

From this point of view, as a result of these initiatives, it is possible to recognize the establishment of the International Industrial Cooperation Center in the border area of both countries. It is planned to equip this center with the necessary production infrastructure. Its residents will have a number of privileges and preferences that will attract Uzbek and Kazakh businessmen to establish joint industrial enterprises. Within the framework of



this cooperation, bilateral agreements on the implementation of joint projects and initiatives with a total value of 5.9 billion dollars were signed⁴.

In addition, in the consultative meetings of the leaders of the Central Asian countries promoted by the President of Uzbekistan, Shavkat Mirziyoyev, the further acceleration of the issues of mutual cooperation in Central Asia, more precisely, the establishment of joint projects in the industrial sector, is put forward as an important issue. In particular, expansion of industrial cooperation is seen as a priority issue. The creation of regional value chains in the Central Asian region, including the creation of industrial and agricultural clusters that reduce production costs, will help to increase the export potential of local producers of finished products.

For example, cooperation between agricultural producers in the region could be aimed at creating joint production facilities for processing fruits and vegetables into finished products for export to third countries. In addition, it is important to continue the practice of establishing joint ventures and industrial cooperation in Central Asian countries in areas where Uzbekistan has the opportunity to increase its export potential (electrical engineering, automotive industry, chemical industry, processing of agricultural products, etc.)⁵.

The proof of the above ideas can be seen in the experience of skills that have been directly applied in practice. As an example, in the American industry, for example, more than 500,000 small firms are currently operating and they produce about 40% of the total volume of products. creates.

There are many small business entities in Spain. Here, small enterprises, which make up 99.7% of the total number of enterprises, provide 70% of the gross industrial product, 75% of exports, and employ 85% of the economically active population. Interestingly, more than 90% of these enterprises are small firms united in the form of cooperation. It can be concluded that ensuring the operation of the industry in a cooperative manner not only ensures the employment of the labor force in the country, but also leads economic entities to effective growth .

In addition to the above, within the framework of the development of inter-industry cooperation, the implementation of the program of localization of the production of finished products, components and materials, business entities will spend 68.4 billion in January-March 2023. A localized product worth soums was produced.

The implementation of measures to increase the volume of localization of the production of finished products, components and materials is one of the factors of the increase in the production of industrial products necessary for the production activity of enterprises and the reduction of imported goods. It seems that industrial cooperation plays a stimulating role. From the point of view of economic theory, industrial cooperation as a form of management can significantly accelerate the pace of economic development. In addition, the promotion of industrial cooperation serves to increase the income of the population, because the number of consumers of the products and services of cooperative companies, as well as the number of people who can organize their own business on the basis of cooperation, is increasing.

During the reporting period, 1920.3 bln. Soum worth of products were produced. The share of joint ventures in industrial production was 50.5 percent.

In 2022, within the framework of the 2022 localization program on the results achieved in the field of localization, the development of cooperative relations in the industry, and the plans for 2023, the production of 140 types of 16,096 pieces of localized products with a value of 21.9 billion soums is set. and 34,195 products of 140 types with a value of 25.9 billion soums were actually produced (118.3% compared to the plan).

The annual plan for the expansion of cooperative relations was set at 154.8 billion soums, and in practice this indicator was fulfilled for 157.1 billion soums (101.5% compared to the specified indicator).

The annual volume of import optimization was planned for 15.6 million dollars, and in practice it reached 16.2 million dollars (103.6% compared to the specified indicator).

This year, as part of the industrial cooperation and localization program, the production of products worth 35.0 billion soums (160% compared to 2022) and the expansion of cooperative relations worth 169.1 billion

soums (107% compared to 2022) .6 %) contracts are expected to be signed. During 2023, it is planned to optimize imports in the amount of 17.2 million dollars due to the production of localized products and the expansion of cooperative relations.

In 2022, the purchase of products worth 154.8 billion soums was forecast for cooperative sales, and in practice, it was fulfilled for 157.1 billion soums or 102%.

By the end of the year, it was planned to reduce imports by 15.6 million dollars, and in practice this figure was 16.2 million dollars (104 percent compared to the plan).

In 2023, within the framework of the localization program, based on 35 projects, the production of products worth 35.0 billion soums and the purchase of products worth 169.1 billion soums through cooperative sales are forecasted.⁷

By the end of the year, it is planned to reduce imports by 17.2 million dollars, which is 110 percent compared to the 2022 plan.

The uniqueness of industrial cooperation is that it reduces the risk of failure in business, creates additional jobs, provides positive experience and knowledge, therefore, it is a factor of entrepreneurship development. All this can serve as a source of economic growth for a country (or a group of countries) and a driving force of the world economy.

During the study of the regional distribution of the industrial sector, the above scientists recognized the forms of industrial cooperation as a factor that accelerates the development of this sector. In addition, the formation of the geography of industrial lands is a process that depends on their concentration in one important place, and not on the geography of human capital. The general point of the theory of many scientists is that industrial enterprises are not dispersed, but they have indicated as an important factor the movement of mutual cooperation. This serves as an incentive for the mobility of industrial entities, that is, from the market and capital flow to the production, distribution and sale of finished products, and has a positive effect on production potential.

CONCLUSIONS AND SUGGESTIONS

From the above analysis and considerations, it can be concluded that modernizing the industry and implementing new methods of production is important in the conditions of modern resource scarcity. Organization of mutual cooperation between industries and enterprises can be a stimulating and effective solution in these processes. The following suggestions and comments should be added as an addition

1. As a result of research, cooperation is an economic phenomenon that manifests itself in the sense of cooperation in economic relations between partners to achieve a common goal with less spending of resources on the basis of mutual benefit for all participants and satisfaction of everyone's interests. It was concluded that the main goal of cooperation is to help agricultural producers in the development of their economy and increase efficiency.
2. In our opinion, the legal basis for further increasing the segment of products created as a result of the cooperation of industrial enterprises and the development of inter-enterprise cooperation is the establishment of new industrial cooperations, their legal and organizational forms, production in the provision of resources, the procedure for organizing relations, product marketing, tax systems, state and should be understood as a set of laws, regulations, which determine the strengthening of relations between cooperatives, mutual relations of cooperatives, and legal guarantees against alienation of property.

Our analysis shows that, on the basis of the principles of organization and formation of industrial products cooperatives, in the production of agricultural products, including the cultivation, processing and storage of industrial products, the improved author's definition of the concepts of "cluster", "cooperation", "cooperative" was developed. In particular, a flawless set of services has been developed, which is distinguished by comparative classification and aims to fully satisfy the needs of the principles of their organization and formation and brings them material and moral benefits at low costs.

3. It was justified that the economic efficiency of fruit and vegetable products can be expressed through criteria and indicators, separating the efficiency indicators of industrial products into technological, economic, social and ecological efficiency types.
4. In the course of the conducted research, the methodology for evaluating the efficiency of industrial products was proposed, the economic efficiency of individual stages of integrated production, final product production, production of industrial products, raw materials, storage of finished products, processing and sales were taken into account
